

## Consumer Health Data Privacy Policy

Effective Date: March 31, 2024

This Consumer Health Data Privacy Policy applies to Consumer Health Data, which refers to all information that identifies or is reasonably linkable to a consumer and that identifies the consumer's past, present, or future physical or mental health status, where the consumer resides in a U.S. state that has enacted a health privacy law (e.g., the Washington and Nevada My Health My Data Acts).

### The Categories of Consumer Health Data We Collect and How We Use Them

We collect the below categories of Consumer Health Data from Consumers.

- Individual health conditions, treatment, diseases, or diagnosis;
- Social, psychological, behavioral, and medical interventions;
- Health-related surgeries or procedures;
- Use or purchase of prescribed medication;
- Bodily functions, vital signs, symptoms, or measurements of health information;
- Diagnoses or diagnostic testing, treatment, or medication;
- Biometric data;
- Genetic data;
- Data that identifies a resident seeking health care services; and
- Any inferences of the above categories of health data derived or extrapolated from non-health information.

We use the above-mentioned categories of Consumer Health Data for the following purposes:

- Providing you with the products, promotions, services, and information you request;
- Contacting you about products, services, and events that we think might be of interest to you;
- Maintaining or administering the Services, performing business analyses, or other internal purposes to improve the quality of our business, the Services, and other products and services we offer;
- Publishing stories, comments, photos, and other information posted in our interactive online features;
- Customizing and personalizing your use of the Services;
- Complying with our legal obligations, satisfying any contract between us and you, establishing and defending any legal claims, and in specific cases processing your information based on your consent; and
- Collecting or processing Consumer Health Data where such collection or processing is not for the purpose of inferring characteristics about a Consumer.

## **The Categories of Sources from Which We Collect Consumer Health Data**

We collect Consumer Health Data directly from you, as well as from the following sources:

- Non-affiliated parties, including those to whom you have previously provided data (e.g., specialty pharmacies);
- Automatically through your devices or browsers when you visit BioMarin's websites and online services;
- We also draw inferences from the information we collect from and about you, such as your preferences, characteristics, attributes, and abilities.

## **The Categories of Consumer Health Data that We Share**

We Share all of the categories of Consumer Health Data that we collect, as described above.

For the purpose of this Consumer Health Data Privacy Policy, "Share" means to release, disclose, disseminate, divulge, make available, provide access to, license, or otherwise communicate orally, in writing, or by electronic or other means, Consumer Health Data to a Third Party or affiliate. Applicable health privacy law may exclude from this definition any disclosure to vendors who process Consumer Health Data on our behalf, disclosure to certain Third Parties with whom you have a direct relationship, and disclosure as part of an asset transfer such as a merger, acquisition, or bankruptcy. "Third Party" means any entity other than our affiliates or vendors who processes Consumer Health Data on our behalf.

## **Third Parties and Affiliates with Whom We Share Consumer Health Data**

We Share Consumer Health Data with Third Parties only where required or permitted by applicable laws, such as government entities.

# Supplement to Consumer Health Data Privacy Policy for Nevada Consumers

Effective Date: March 31, 2024

This Supplement applies to Nevada Consumers for purposes of providing additional disclosures required by Nevada's Consumer Health Data privacy law.

**Purposes & Manner of Processing.** We collect, use, process, and Share Consumer Health Data for the purposes and in the manners described in our Consumer Health Data Privacy Policy, which also provides additional disclosures relevant to Nevada Consumers.

**Review & Revision of Consumer Health Data.** If you would like to review and/or revise your Consumer Health Data, you may submit a request to us via any of the methods listed in our Consumer Health Data Privacy Policy. We will respond to your requests to exercise your rights in accordance with applicable law, but in any case no later than 45 days after receiving your request. We may extend this period by up to 45 days only where doing so is permitted under applicable law.

**Changes to this Supplement.** We will notify you before making any changes to our privacy practices with respect to your Consumer Health Data by posting an updated notice on this page, with an updated effective date.

**Third Party Collection of Consumer Health Data.** We limit Third Party collection of Consumer Health Data over time and across different websites or online services when the Consumer uses our websites or online services. We do this by ensuring that entities whose cookies, web beacons, pixels, and other online trackers we use on our websites and online services process Consumer Health Data on our behalf, in accordance with applicable U.S. privacy laws including health privacy laws. Nonetheless, please note that Third Parties may still be able to collect Consumer Health Data from you over time and across different websites depending on your browser, browser add-ons, and associated permissions you set on your device. This collection of Consumer Health Data by those Third Parties is unrelated to BioMarin's collection of Consumer Health Data from you, and we encourage you to view those Third Parties' privacy notices for more information about their processing of Consumer Health Data and the methods they provide to allow you to opt out of such processing.
